## Remarks

(2) On 7/14/23, MJH Partners II LLC transferred 1,000,000 shares of Common Stock to MJH Partners III LLC in a share contribution in which the ultimate beneficial ownership of such shares did not change. No funds or consideration was paid for such transfer. Each of MJH II and MJH III is an estate planning vehicle for which Joshua Harris exercises voting and investment control. In accordance with the interpretive letter from the staff of the SEC to Goldman Sachs, dated 12/20/99, and in the interpretive letter from the staff of the SEC to Bank of America, N.A. et al, dated 12/1/11, on the date hereof, MJH Partners III LLC has entered into delayed draw variable share forward sale transactions which relate to up to the aggregate number of shares of Common Stock specified in Part 3(c) above. The delayed draw variable share forward sale transactions are with an unaffiliated bank, and may be physically settled or cash settled. Part 3(d) is based on the closing price of \$80.55 on July 13, 2023.
