Explanation of Responses:

1. Represents restricted stock units ("RSUs") granted under the Apollo Global Management, Inc. 2019 Omnibus Equity Incentive Plan (the "Plan"). Each RSU represents the contingent right to receive, in accordance with the issuance schedule set forth in the applicable RSU award agreement, one share of common stock of the Issuer for each vested RSU. The RSUs vest in installments in accordance with the terms of the applicable RSU award agreement, provided the reporting person remains in service through the applicable vesting date. Pursuant to a deferral election, the associated shares of common stock will be issued upon the reporting person's termination of service as a member of the Board of Directors of the Issuer.

2. Reported amount includes 6,061 RSUs granted under the Plan.

3. These shares of common stock are held in the Alvin B. Krongard Family Trust (the "Trust") for the benefit of the reporting person's children for which the reporting person's children are the trustees. The reporting person disclaims beneficial ownership of the shares of common stock held in the Trust, except to the extent of his pecuniary interest therein.

4. These shares of common stock were previously reported as directly held by the reporting person. These shares of common stock are held in the Cheryl Krongard Family Trust (the "Family Trust") for the benefit of the reporting person for which the reporting person's children are the trustees. The reporting person disclaims beneficial ownership of the shares held in the Family Trust, except to the extent of his pecuniary interest therein.
